## **PRIVACY POLICY**

	We may disclose User Provided and Automatically Collected Information: (1) as required by law, such as to comply with a subpoena, or similar legal process; (2) when We believe in good faith that disclosure is necessary to protect Our rights, protect Your safety or the safety of others, investigate fraud, or respond to a government request; (3) with Our trusted services providers who work on Our behalf, do not have an independent use of the information We disclose to them, and have agreed to adhere to the rules set forth in this privacy statement; or (4) if Company is involved in a merger, acquisition, or sale of all or a portion of its assets, You will be notified via email and/or a prominent notice on Our

	Site of any change in ownership or uses of this information, as well as any choices You may have regarding this information.

DATA RETENTION & MANAGEMENT	We will retain User Provided data for as long as You use the Site and for a reasonable time thereafter. We will retain Automatically Collected information for up to 24 months and thereafter may store it in aggregate. SECURITY	We are concerned about safeguarding the confidentiality of Your information. We provide physical, electronic, and procedural safeguards to protect information We process and maintain. Please be aware that, although We endeavor provide reasonable security for information We process and maintain, no security system can prevent all potential security breaches.
